### **Report on Industrial Visit to Richter-Themis Medicare(I) Pvt. Ltd, GIDC, Vapi**

The Department of Chemistry organized an industrial visit for the final year students of B.Sc. (Chemistry) to Richter-Themis Medicare(I) Pvt. Ltd, GIDC, Vapi on 23<sup>rd</sup> December, 2022 from 2:00 PM onwards. A total of 39 students and 03 faculty members (Dr. Himanshu D. Patel, Dr. Sureshkumar L. Chavda and Dr. Sony Amrendra) of the department had taken part in the visit.

The bus organised by the college administration left the college campus at 2:00 pm and we reached the site at around 2:30 pm. After the initial entry pass formalities at the gate the faculty members and students were greeted and guided by Himanshu Patnaik (Production), Rakesh Mathews (HR Manager), Suresh Saini (Production), Tushar Desai (R & D), Pradip Bedge (Quality Analysis), and We were first taken to the canteen wherein all were provided with tea.

The representatives Suresh Saini (Production), Pradip Bedge (Quality Analysis), Tushar Desai (R & D), first briefed about the company. The pharmaceutical company Richter-Themis Medicare(I) Pvt. Ltd. is a Multi-National Company (operating from Hungary) established in the year 2004 in the GIDC area, Vapi. Here almost 300 people were working in three shifts. The pharmaceutical industry mainly dealt with the synthesis of intermediates as raw materials for various medicines. After a short briefing, the personnel from the industry Rakesh Mathews (HR manager) divided the group in three batches of 12-13 students per batch and each batch was led by one representative and one faculty member.

Further, the groups were individually briefed about the establishment and the various process that takes place in the industry right from collection of raw materials, storage, chemical reactions, quality check, quarantine to dispatch of the finished goods.

The representatives showed us how the raw materials were collected, processed and dispatched after strict quality control and the whole process was shown. We were initially taken to the changing rooms wherein the workers had individual lockers and changing rooms were provided. Each worker was given Personal Protection kits which was mandatory. We were then guided through the storage area where the raw materials were collected and stored. We were then taken to the actual site where the production was carried in large scale. There they briefed us on the various reactors, centrifuge, distillation set ups, and reaction condition set up for the reactors.
